### **EXECUTIVE ORDER NO. 004 Series of 2019**

#### **REORGANIZING THE MUNICIPAL DEVELOPMENT COUNCIL OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE**

**WHEREAS**, the Municipal Development Council, as provided for RA 7160, shall be composed of the Mayor as Chairman, the Sangguniang Bayan Member Chairman, Committee on Appropriations, the Liga ng mga Barangay President, all Punong Barangays, the Congressman of the District or his representative, and representatives of Non-Government Organizations operating within the municipality, as Members;

**WHEREAS**, there is a need to re-organize the Municipal Development Council in order to ensure that members of the council who have transferred, resigned, promoted, terminated, or separated from the service as result of election, be properly replaced;

**NOW THEREFORE, I, JOSEPH E. DE LARA**, Municipal Mayor of the Municipality of Solsona, Province of Ilocos Norte, by virtue of the powers vested in me by law, hereby order that:

**Section 1. Re-organization and Composition.** The council shall be composed of the following:

**Section 2. Duties and Functions.** The Municipal Development Council shall have the following duties and functions.

1. Formulate long term, medium-term, and annual socio-economic development plans and policies;
2. Formulate medium-term and annual public investment programs;
3. Evaluate and prioritize socio-economic development programs and projects;
4. Formulate local investment incentives to promote the inflow and direction of private investment capital;
5. Coordinate, monitor and evaluate the implementation of development programs and projects; and
6. Perform such other functions as maybe provided by law or component authority.

**Section 3. Secretariat.** There shall be constituted Secretariat responsible for providing technical and administrative support, documenting proceedings, preparing reports and providing for such other assistance as may be required by the Municipal Development Council. The Secretariat shall be headed by the Municipal Planning and Development Coordinator.

**Section 4. Executive Committee (Composition, Powers and Functions).** There shall be constituted Executive Committee of the Municipal Development Council composed of the following:

The Executive Committee shall have the following powers and functions:

1. Ensure that the decisions of the MDC are faithfully carried out and implemented;
2. Act on matters that need immediate attention and action of the MDC;
3. Formulate policies, plans, and programs based on the objectives and priorities set by the MDC; and
4. Take final action on matters that may be authorized by the LDC except the approval of local development plans and annual investment plans.

**Section 5- Repealing Clause-** All Executive Orders, rules and regulations and other issuances or parts thereof inconsistent with this Executive Order are hereby repealed and modified.

**Section- EFFECTIVITY-** This Executive Order shall take effect immediately upon approval.

**SO ORDERED.**
