EXECUTIVE ORDER NO. 005 Series of 2019

REORGANIZATION OF THE MUNICIPAL SCHOOL BOARD OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE

WHEREAS, Section 98, Title IV of Republic Act 7160 also known as the Local Government Code of 1991 provides for the creation of Local School Board in every municipality;

WHEREAS, there is an existing Local School Board of the municipality created by Executive Order No. 51 series of 2016;

WHEREAS, there is a need to reorganize the Local School Board of the municipality in order to ensure that members of the board who have transferred, resigned, promoted, terminated, or separated from the service as result of election, be properly replaced;

NOW THEREFORE, I, JOSEPH E. DE LARA, by the powers vested in me by law as the Mayor of Solsona, Ilocos Norte, do hereby reorganize the Municipal School Board of the municipality of Solsona, Ilocos Norte.

Section 1. Reorganization and Composition. The following shall compose the Municipal School Board of the municipality of Solsona, Ilocos Norte;

Section 2. Duties and Functions. The Municipal School Board shall have the following duties and functions:

1. Determine in accordance with the criteria set by DepEd the annual supplemental budgetary needs for the operation and maintenance of public schools within the municipality and the supplementary local cost of meeting, such needs shall be reflected in the form of Annual School Board budget corresponding to its share of the proceeds of the special levy on real property, constituting the special education fund and such other sources of revenue as the code and other laws or ordinance may provide;
2. Authorize the Municipal Treasurer to disburse funds from special education fund pursuant to the budget prepared in accordance with applicable existing rules and regulations;
3. Serve as advisory committee to the Sangguniang concerned on educational matters such as, but not limited to the necessity for and the uses of local appropriations for educational purposes; and
4. Recommend changes in the names of public schools within the territorial jurisdiction of the LGU for enactment by the Sanggunian concerned.

Section 3- Repealing Clause- All Executive Orders, rules and regulations and other issuances or parts thereof inconsistent with this Executive Order are hereby repealed and modified.

Section- EFFECTIVITY- This Executive Order shall take effect immediately upon approval.
