EXECUTIVE ORDER NO. 006 Series of 2019

REORGANIZING THE MUNICIPAL HEALTH BOARD OF SOLSONA, ILOCOS NORTE

WHEREAS, Section 102, Title Five of RA 7160 mandates the establishment in every province, city and municipality a Local Health Board;

WHEREAS, there is a need to reorganize the Municipal Health Board of Solsona, Ilocos Norte due to change of local officials and employees as a result of the local and national election last May 13, 2019;

NOW THEREFORE, I, JOSEPH E. DE LARA, Municipal Mayor of the Municipality of Solsona, Province of Ilocos Norte, by virtue of the powers vested in me by law, hereby order that:

Section 1. **Reorganization and Composition.** The Municipal Health Board is hereby reorganized with the following composition:

Section 2. **Duties and Functions of the MHB.** The Municipal Health Board shall have the following functions:

1. To propose to the Sangguniang Bayan Member concerned, in accordance with the standards and criteria set by DOH, Annual Budgetary Allocations for the operation and maintenance of health facilities and services within the municipality;
2. To serve as an Advisory Committee to the Sanggunian concerned on health matters such as but not limited to, the necessity for, and application of local appropriations for public health purposes;
3. Create Committees which shall advise local health agencies on matters such as, but not limited to, technical and administrative standards of DOH, personnel selection and promotion, bids and awards, grievance and complaints, personnel discipline, budget review and similar functions.

Section 3. **Effectivity.** This Executive Order shall take effect immediately upon approval.
