**AMENDING SECTION 1 EXECUTIVE ORDER NO. 005, SERIES OF 2019,
REORGANIZING THE MUNICIPAL SCHOOL BOARD (MSB) OF THE MUNICIPALITY OF

WHEREAS, there is already an existing Municipal School Board (MSB) of the Municipality of Solsona pursuant to Republic Act No. 7160 otherwise known as the Local Government Code of 1991;


WHEREAS, the said Municipal School Board (MSB) was last reorganized on July 12, 2019, per Executive Order No. 005, s. 2019 signed by the Local Chief Executive as amended by Executive Order No. 068, s. 2019;

WHEREAS, Republic Act No. 7160 otherwise known as the Local Government Code of 1991 prescribes the involvement of Civil Society Organizations (CSOs) in the Municipal School Board;

WHEREAS, in order to conform with existing policy guidelines, there is a need to amend the composition of the Municipal School Board (MSB) of Solsona, Ilocos Norte;

NOW THEREFORE, by virtue of the power vested in me by law as the Municipal Mayor of Solsona, Ilocos Norte, do hereby order the amendment of Section 1 of Executive Order No. 005, Series of 2019 of the Municipal School Board (MSB) as follows:
