EXECUTIVE ORDER NO. 011 Series of 2019

REORGANIZATION OF TECHNICAL WORKING GROUP FOR THE FORMULATION OF FOREST LAND USE PLAN OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE

WHEREAS, RA 7160 otherwise known as the Local Government Code of 1991 mandates Local Government Units to share with the National Government, the responsibility in the management, maintenance, protection and sustainable development of the environment and natural resources within their respective jurisdiction;

WHEREAS, Joint Memorandum Circular No. 98-01 of the DENR and DILG mandate the Local Government Units and Department of Environment and Natural Resources in collaboration with other National Government Agencies to undertake forest land use as an integral activity of their Comprehensive Land Use Planning to determine the optimum and balanced use of natural resources to support local, regional and national growth and development;

WHEREAS, to strengthen and institutionalize the DENR-DILG-LGU partnership on devolved and other forest land use plan management functions, the DENR-DILG further issued Joint Memorandum Circular No. 2003-01 dated May 19, 2003 to accelerate and fast-track the collaboration and coordination and institutionalization of the working relationship among these agencies on the devolved and other forest management functions;

WHEREAS, the DENR and the Local Government Unit of Solsona, Ilocos Norte realize the urgency of protecting, conserving and managing the forests and forestland within the jurisdiction of the municipality;

WHEREAS, the DENR and the municipality of Solsona, Ilocos Norte have agreed through a Memorandum of Agreement to jointly undertake the formulation of the Forest Land Use Plan of the municipality;

WHEREAS, there is an imperative need for the reorganization of the Technical Working Group (TWG) of the municipality to take charge in the preparation of the Forest Land Use Plan of the municipality in coordination with the Technical Working Group (TWG) of the province under the supervision of the DENR and due to the change of local officials brought about by the national and local election last May 13, 2019;

NOW THEREFORE, I, JOSEPH E. DE LARA, Municipal Mayor of the municipality of Solsona, Ilocos Norte by virtue of the powers vested in me by law, hereby promulgate;

Section 1. REORGANIZATION AND COMPOSITION. The Technical Working Group (TWG) of the Municipality for the Formulation of the Forest Land Use Plan of the municipality is hereby created and shall be composed of the following;

Section 2. POWERS, DUTIES AND FUNCTIONS OF THE TECHNICAL WORKING GROUP (TWG)

1. Coordinate with the DENR and the Provincial Technical Working Group (TWG) for the Forest Land Use Planning in the collection of data/information needed in the formulation of the Forest Land Use Plan (FLUP) of the municipality.

Section 3- Repealing Clause. All Executive Orders, rules and regulations and other issuances or parts thereof inconsistent with this Executive Order are hereby repealed and modified.

Section 4- EFFECTIVITY. This Executive Order shall take effect immediately upon approval.
