### EXECUTIVE ORDER NO. 012 Series of 2019

#### REORGANIZING OF THE MUNICIPAL ANTI-DRUG ABUSE COUNCIL (MADAC) OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE

**WHEREAS**, the Department of the Interior and Local Government issued MC No. 2012-94 on May 21, 2012 strengthening and activating the Municipal Anti- Drug Abuse Council (MADAC)

**WHEREAS**, there is need to update the composition of the MADAC in the municipality of Solsona in order to address urgent concerns indicated in MC No. 2012-94;

**WHEREAS**, there is a need to reorganize the Municipal Anti-Drug Abuse Council (MADAC) due to the change of local officials brought about by the local and national elections last May 13, 2019;

**NOW THEREFORE, I, JOSEPH E. DE LARA**, by the powers vested in me by law as the Municipal Mayor of Solsona, Ilocos Norte, do hereby reorganize the Municipal Anti-Drug Abuse Council of the Municipality of Solsona, Ilocos Norte.

**Section 1. Composition.** The following shall compose the Municipal Anti-Drug Abuse Council of the Municipality of Solsona, Ilocos Norte;

**Section 2. Duties and Function.** The MADAC shall have the following duties and functions:

- a. Serve as a focal point through various organizations and individuals work together cooperatively in planning, implementation and evaluation of programs on drug abuse prevention;
- b. Provide for an effective mechanism for the coordination of existing services and programs and those which might be developed in the immediate future;
- c. Provide for a mechanism to obtain funds, volunteers, facilities and technical expertise.

**Section 3. Repeating clause.** All Executives Orders, Rules and Regulations and other Issuances or parts thereof inconsistent with this Executive Order are hereby repealed and modified.

**Section 4. Effectivity.** This Executive Order shall take effect immediately upon its approval.
