EXECUTIVE ORDER NO. 016 Series of 2019

REORGANIZING THE GAD MONITORING AND EVALUATION (M&E) TEAM OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE

WHEREAS, Section 16 and 17 of Title I, Chapter I of the Republic Act No. 7160 otherwise known as the Local Government Code of 1991 where every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Joint Memorandum Circular 2013-01 of the PCW, DILG, DBM, and NEDA mandates all local government unit to recognize the GAD Monitoring and Evaluation Team;

WHEREAS, there is a need to reorganize the GAD Monitoring and Evaluation Team of Solsona, Ilocos Norte due to change of local officials and employees as a result of the local and national elections last May 13, 2019;

NOW THEREFORE, I, Hon. JOSEPH E. DE LARA, by the powers vested in me by law as the Mayor of Solsona, Ilocos Norte, do hereby reorganize the GAD Monitoring and Evaluation Team of the Municipality of Solsona, Ilocos Norte, as follows:

Section I. Reorganization and Composition of the GAD Monitoring and Evaluation Team of Solsona, Ilocos Norte:

Section 2. Duties and Functions. The GAD Monitoring and Evaluation Team shall have the following duties and functions:

1. Establish, enhance, strengthen and/or maintain a gender responsive monitoring and evaluation (M&E) system;
2. To strengthen LGU-LGU and LGU-NGA relations on GAD planning, programming, budgeting, project development, implementation, monitoring and evaluation; and
3. Shall ensure active participation of local committees/ councils in partnership with national/regional government agencies, academe, private sector and civil society organizations (CSO's) operating at the local for effective gender mainstreaming.

Section 3. Repealing Clause. All Executive Orders, Rules and Regulations and other issuances or parts thereof inconsistent with this Executive Order are hereby repealed and modified.

Section 4. Effectivity. This Executive Order shall take effect immediately upon its approval.
