EXECUTIVE ORDER NO. 021 SERIES OF 2019

REORGANIZING THE MUNICIPAL COUNCIL FOR THE PROTECTION OF CHILDREN (MCPC) OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE

WHEREAS, the Department of the Interior and Local Government (DILG) Memorandum Circular No. 2002-121 dated August 5, 2002 mandates the establishment of Local Council for the Protection of Children;

WHEREAS, The DILG shall be responsible in overseeing the organization and functionality of the MCPC;

WHEREAS, there is an existing Municipal Council for the Protection of Children of the Municipality but there is a need to reorganize the same due to the change of Local officials brought about by the national and local elections last May 13, 2019;

NOW THEREFORE, I, JOSEPH E. DE LARA, Municipal Mayor of Solsona, Ilocos Norte by virtue of the power and authority vested in me by law, do hereby order that:

Section 1. Composition. The Composition of the Municipal Council for the Protection of Children of Solsona, Ilocos Norte shall be composed of the following:

Section 2. Functions. The Municipal Council for the Protection of Children of the Municipality of Solsona, Ilocos Norte shall have the following functions:

1. Formulate plans, programs and policies for children that are gender fair, culturally relevant and responsive to the needs of diverse groups of children from 0-8 years of age;
2. Prepare AWWP for children and recommend appropriations to the Sangguniang Bayan;
3. Provide coordinative linkages with other agencies and institutions in the planning, monitoring and evaluation of plans for children;
4. Provide technical assistance and recommend financial support to the Barangay Council for the Protection of Children;
5. Establish and maintain database on children in the municipality;
6. Foster education for every children;
7. Advocate for the establishment and maintenance of playgrounds, day care centers and other facilities necessary for child and youth development;
8. Recommend local legislations promoting child survival, protection, participation and development and with appropriate funding support;
9. Assist children I need of special protection ad refer cases filed against child abusers to proper agencies/institutions;
10. Conduct capability-building programs to enhance knowledgeable and skills in handling children's programs;
11. Document Barangay's best practices for children;
12. Monitor and evaluate the implementation of the program and submit quarterly status reports to PCPC; and

13. Perform such other functions as provided in the ECCD and other child related laws.

Section 3. Repeating Clause. All Executive Orders, Rules and Regulations and other issuances or parts thereof inconsistent with this Executive Order hereby repealed and modified.

Section 4. Effectivity. This Executive Order shall take effect immediately upon its approval.
