EXECUTIVE ORDER NO. 023 Series of 2019

REORGANIZING THE MUNICIPAL NUTRITION COUNCIL OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE

WHEREAS, the Municipal Nutrition Council is the arm for planning, implementing, monitoring, evaluation and coordinating the municipal plan of action for nutrition;

WHEREAS, the concern of nutrition is one of the targets of the Millenium Development Goals, particularly the eradication of hunger and poverty of which the municipal target is "reducing by 100% of the number of underweight children (0-6 years old) and increasing by 50-0% the number of households eating the minimum level of dietary energy foods;

WHEREAS, there is a need to reorganize the Municipal Nutrition Council of Solsona, Ilocos Norte due to the change of local officials and employees as a result of the local and national elections last May 13, 2019;

NOW THEREFORE, I, HON. JOSEPH E. DE LARA, by virtue by the powers vested in me by law as the Municipal Mayor of Solsona, Ilocos Norte, do hereby order the reorganization of the Municipal Nutrition Council of the Municipality of Solsona, Ilocos Norte, as follows:

Section 1. Composition and Reorganization of the Municipal Nutrition Council of the Municipality of Solsona, Ilocos Norte:

Section 2. Duties and Functions. The Municipal Nutrition Council shall have the following duties and functions:

1. Formulate and implement local food and nutrition policies, plans and interventions for nutrition improvement;
2. Monitor and evaluate the efficiency and effectiveness of the plan for nutrition improvement;
3. Identify and mobilize local resources for nutrition interventions; and
4. Advocate for local support for the nutrition plan to sustain nutrition improvement.

Section 3. Repealing Clause. All Executive Orders, Rules and Regulations and other issuances of parts thereof inconsistent with this Executive Order are hereby repealed and modified.

Section 4. Effectively. This Executive Order shall take effect immediately upon its approval.
