EXECUTIVE ORDER NO. 023 Series of 2020

AMENDING SECTION 1 OF EXECUTIVE ORDER NO. 012 SERIES OF 2019, TITLED "REORGANIZING OF THE MUNICIPAL ANTI-DRUG ABUSE COUNCIL (MADAC) OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE"

WHEREAS, the Chief Executive issued Executive Order No. 012, Series of 2019 dated July 15, 2019.

WHEREAS, there is a need to reorganize the Municipal Anti-Drug Abuse Council (MADAC) due to the change of designations and positions within the organization.

WHEREAS, the Department of the Interior and Local Government issued MC No. 2012-94 on May 21, 2012 strengthening and activating the Municipal Anti- Drug Abuse Council (MADAC)

WHEREAS, there is need to update the composition of the MADAC in the municipality of Solsona in order to address urgent concerns indicated in MC No. 2012-94;

NOW THEREFORE, I, JOSEPH E. DE LARA, by the powers vested in me by law as the Municipal Mayor of Solsona, Ilocos Norte, do hereby reorganize the Municipal Anti-Drug Abuse Council of the Municipality of Solsona, Ilocos Norte.

Section 1. Section 1 of Executive Order No. 012, Series of 2019 is hereby amended and read as follows:
