EXECUTIVE ORDER NO. 024 Series of 2019

REORGANIZING THE MUNICIPAL COUNCIL OF THE INDIGENOUS PEOPLE OF SOLSONA, ILOCOS NORTE

WHEREAS, Section 22, Article II of the 1987 Constitution provides that, The State recognizes and promotes the rights of Indigenous Cultural Communities within the framework of national unity and development;

WHEREAS, the Republic Act No. 8371, recognizes, protects and promotes the rights of indigenous Cultural Communities/Indigenous People and the state recognizes its obligations to respond to the strong expression of the ICC's/IP's for cultural integrity and assuring maximum participation in the direction of education, health as well as other services;

WHEREAS, the Municipality of Solsona recognizes the right and participation of Indigenous Cultural Communities/Indigenous People residing in the municipality of Solsona, Ilocos Norte;

WHEREAS, there is a need to reorganize the Municipal Council of Indigenous People of the Municipality of Solsona in order to achieve the said goal and promote better services and recognition to ICC's/IP's;

WHEREAS, there is a need to reorganize the Municipal Council of Indigenous People of the Municipality because of the change of municipal officials and employees as a result of the national and local elections last May 13, 2019;

NOW THEREFORE, I, JOSEPH E. DE LARA, Municipal Mayor of Solsona, Ilocos Norte by virtue of the power vested in me by law, do hereby order the reorganization of the Municipal Council of Indigenous People of the Municipality of Solsona, Ilocos Norte.

Section 1. The following shall compose the Municipal Council of Indigenous People of the Municipality of Solsona:

Vice-Chairman	-	HON. NORBERTO L. AGULAY <i>Chairman, Committee on Education and Culture</i>
Members	-	MRS. NELLIE BAGO <i>IP Representative</i>

		MRS. BELLA B. BALLESTEROS <i>Municipal Social Welfare & Development Officer</i>

Section 2. Duties and Functions:

1. Ensure continuing dialogue and coordination among all stake holders in the municipality for the proper implementation of program and projects to ICC's/IP's;
2. Request the assistance of any government agency and instrumentality in order to achieve the purpose of this council;
3. To meet at least on quarterly basis or as may be necessary; and
4. Perform such other functions and acts as may be necessary proper or incidental to attainment of its mandates as may be necessary and as directed by the local chief executive.

Section 3. Repealing Clause. All Executive orders, Rules and Regulations and other issuance or parts thereof inconsistent with this Executive Order are hereby repealed and modified accordingly.

Section 4. Effectivity. This Executive Order shall take effect immediately upon its approval.
