### EXECUTIVE ORDER NO. 029 Series of 2019

#### REORGANIZING THE MUNICIPAL PEACE AND ORDER OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE

**WHEREAS**, one of the basic services to be provided by the Municipality as indicated in the Local Government Code is the maintenance of public order and safety in the municipality.

**WHEREAS**, Section 116 of Republic Act 7160 and Executive Order 309 as amended, mandates the establishment in every municipality, a Local Peace and Order council to fully coordinate and effectively prevent and suppress criminality in the municipality.

**WHEREAS**, there is a need to reorganize the Municipal Peace and Order Council due to the change of local and national employees stationed in the municipality as a result of transfer and reshuffling.

**NOW THEREFORE**, I, **JOSEPH E. DE LARA**, by the powers vested in me by law as Municipal Mayor of Solsona, Ilocos Norte, do hereby reorganize the Municipal Peace and Order Council of the Municipality of Solsona, Ilocos Norte.

**SECTION 1. COMPOSITION:** The following shall compose the Municipal Peace and Order Council;

**Section 3.** The Municipal Peace and Order Council Secretariat shall be composed of the following duties and functions:

- a.) Formulate plans and recommend such measures which will improve or enhance peace and order and public safety in the municipality;
- b.) Monitor the implementation of peace and order programs and projects of the municipality;
- c.) Monitor operation of the Civilian Volunteer Self-Defence organizations (CAFGO) and other counter insurgency programs and activities;
- d.) Conduct periodic assessment of the prevailing peace and order and public safety situation in the municipality and report to the National Peace and Order Council the assessment result for appropriate action; and
- e.) Perform all other allied duties and functions as may be required by law, the President of the National Peace and Order Council.

**Section 4.** Duties and Functions of the Municipal Peace and Order Secretariat:

- a.) Shall prepare plans and programs for the consideration of the MPOC;
- b.) Supervise, monitor and direct the implementation of programs, projects and activities of approved policies, plans and programs of the municipality relative to peace and order and public safety; and
- c.) Act as liaison and coordination link of activities with appropriate agencies/offices of the government and provide a forum for inter-agency dialogue and deliberation of major issues/problems relative to peace and order and public safety.

**Section 5.** The Executive Order shall take effect immediately upon its approval.
