EXECUTIVE ORDER NO. 036 Series of 2019

REORGANIZING THE LOCAL COUNCIL ON ANTI-TRAFFICKING AND VIOLENCE AGAINST WOMEN AND THEIR CHILDREN (LCAT-VAWC) OF SOLSONA, ILOCOS NORTE

WHEREAS, there is already an existing Local Council on Anti-Trafficking and Violence Against Women and their Children (LCAT-VAW) organized in accordance with law particularly Republic Act No. 9208 and Joint Memorandum Circular No. 2010-1 of the Department of the Interior and Local Government, Department of Social Service and Development and the Department of Justice dated October 18, 2010;

WHEREAS, this Council is organized and established to strengthen government structures and mechanism to address the problem of Trafficking and Violence Against Women and their Children;

WHEREAS, there is a need to reorganize the LCAT-VAWC of the municipality due to the change of local officials and employees as a result of the local and national elections on May 13, 2019 in order to revitalize it and activate it to undertake programs, projects and measures to promote human dignity and integrity, protect the people from violence and exploitation, eliminate human trafficking and mitigate if not eliminate pressures for involuntary migration and servitude of persons to ensure their recovery, rehabilitation, development and reintegration;

NOW THEREFORE, I, JOSEPH E. DE LARA, Municipal Mayor of Solsona, Ilocos Norte by virtue of the powers vested in me by law as the Local Chief Executive do hereby reorganize the Local Council on Anti-Trafficking and Violence Against Women and their Children (LCAT-VAWC) of the Municipality of Solsona, Ilocos Norte, as follows:

Section 1. REORGANIZATION AND COMPOSITION. Composition of the Local Council on Anti-Trafficking and Violence Against Women and their Children (LCAT-VAWC) of the municipality of Solsona, Ilocos Norte shall be as follows:

Section 2. DUTIES AND FUNCTIONS: The Local Council on Anti-Trafficking and Violence Against Women and their Children (LCAT-VAWC) of Solsona, Ilocos Norte shall perform the following duties and functions:

1. Formulate plan and undertake programs, projects and activities to protect women and children against trafficking violence and abuses;

2. Enactment of policies and measures thru the SB for systematic surveillance, investigation and mitigation of trafficking and violence against women and children;
3. Recommend to SB, enactment of ordinance to prevent/mitigate trafficking and acts of violence against women and children
4. Conduct information, education, and advocacy campaign against trafficking of person and violence against women and children; and
5. Monitor the strict implementation of R.A. No. 9208 and other related laws and regulations for the protection of women and children particularly adopted action plan of the LCAT-VAWC.

Section 3. DUTY AND FUNCTION OF THE SECRETARIAT:

1. To assist the Council in the undertaking of its programs, projects, activities and in its implementation.

Section 4. REPEALING CLAUSE. All Executive Orders, Rules and Regulations and other Issuances or parts thereof inconsistent with this Executive Order are hereby repealed and modified.

Section 5. EFFECTIVITY. This Executive Order shall take effect immediately upon its approval.
