EXECUTIVE ORDER NO. 037 **Series of 2019**

REORGANIZING THE LOCAL COUNCIL FOR WOMEN OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE

WHEREAS, the Local Council for Women (LCW) of the municipality of Solsona, Ilocos Norte was duly organized pursuant to the mandates of Republic Act No. 7192 otherwise known as the Women in Development and Nation Building Act and in compliance to DILG MC 2002-167;

WHEREAS, there is a need to activate this Council to serve as a mechanism to mainstream all Gender and Development Programs, Projects and Activities to pursue women empowerment, gender sensitivity, social justice and sustainable development in the municipality;

WHEREAS, membership in the council need changes due to the change of local officials and employees as a result of the May 13, 2019 local and national elections;

NOW THEREFORE, I, JOSEPH E. DE LARA, Municipal Mayor, Solsona, Ilocos Norte by virtue of the powers vested in me by law, hereby order the reorganization of the Local Council for Women of Solsona, Ilocos Norte, to wit:

Section 1. Composition. The Local Council for Women (LCW) of Solsona, Ilocos Norte shall be composed of the following:

Section 2. Duties and Functions: The Local Council for Women shall have the following duties and functions:

1. Involve the women sector in the implementation of the local government unit's programs, projects and activities particularly planning, implementation and legislation;
2. Lead more women to get involve in the social, civic, and political activities in the municipality;
3. Serves as a vehicle in the mainstreaming of women in the pursuit of peace, equality and sustainability development;
4. Ensure participation of women in local governance by ensuring representation of women to local special bodies;
5. Serve as a vehicle in mainstreaming gender and development in the local government unit and the passage of local legislation addressing gender issues and women's concern;
6. Undertake projects and activities such as livelihood, micro-enterprise, social services, trainings and skills development in partnership with the local government unit, NGOs, POs and other government agencies; and
7. Initiate and contribute to the awareness-raising, consciousness broadening and public debate of GAD-related issues and concerns, especially Violence against Women and their Children, sexual, reproductive and health rights through projects and programs concerning the same.

Section 3. Repealing Clause. Any law, orders and other administrative issuances inconsistent with this Executive order are hereby repealed and modified.

Section 4. EFFECTIVITY. This Executive Order shall take effect immediately after its approval.
