EXECUTIVE ORDER NO. 038 Series of 2019

REORGANIZING THE LOCAL HIV/AIDS COUNCIL OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE

WHEREAS, Republic Act No. 8504 or known as the Philippine AIDS Prevention and Control Act of 1998, provides that the state shall promote public awareness for the prevention and control of HIV/AIDS through a nationwide educational campaign;

WHEREAS, Section 196 of Municipal Ordinance No. 2012-593 mandates for the creation of a Local Aid Council to conceptualize and implement projects to protect the residents and tourists from threat of AIDS through a more responsive health care system and programs for the upliftment of persons infected with the said disease;

WHEREAS, Section 12, Article XIII of the Philippine Constitutions, provides that the State shall establish and maintain an effective food and drug regulatory system and undertake appropriate health manpower development and research, responsive to the country' health needs and problems;

WHEREAS, there is a need to re-organize the the Local HIV/AIDS Council of Solsona, Ilocos Norte due to the change of local officials brought about by the local and national elections last May 13, 2019;

NOW THEREFORE, I, JOSEPH E. DE LARA, Municipal Mayor of Solsona, Ilocos Norte by virtue of the powers vested in me by law as the Local Chief Executive do hereby reorganize the Local HIV/AIDS Council of the municipality of Solsona, Ilocos Norte, to wit:

Section 1. REORGANIZATION. The Local HIV/AIDS Council is hereby reorganized which shall be composed of the following:

Chairperson: HON. JOSEPH E. DE LARA - Municipal Mayor

Vice Chairperson: HON. NORBERTO L. AGULAY - SBM, Chairman- Committee on Health and Social Welfare

Section 2. DUTIES AND FUNCTIONS: The Local HIV/AIDS Council shall perform the following duties and functions:

1. To develop a Municipal HIV/AIDS Prevention and Control Plan;
2. To provide an acceptable health support service for individuals with HIV/AIDS in hospitals and in communities;
3. To ensure the protection and promotion of the rights of individuals with HIV/AIDS;
4. To coordinate and cooperate with the provincial, national and non-government organizations regarding data collection, research and treatment modalities concerning HIV/AIDS; and
5. To evaluate the adequacy of resources and make recommendations regarding the utilization of national resources for the prevention and control of HIV/AIDS in the municipality.

Section 3. REPEALING CLAUSE. All Executive Orders, Rules and Regulations and other Issuances or parts thereof inconsistent with this Executive Order are hereby repealed and modified.

Section 4. EFFECTIVITY. This Executive Order shall take effect immediately upon its approval.
