EXECUTIVE ORDER NO. 039 Series of 2019

REORGANIZATION AND DESIGNATION OF THE MEMBERS OF MUNICIPAL ADVISORY COMMITTEE AND MUNICIPAL INTERAGENCY COMMITTEE TO IMPLEMENT THE PANTAWID PAMILYANG PILIPINO PROGRAM (4P's) AND THE CONVERGENCE STRATEGY PROGRAM IN THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE

WHEREAS, Pantawid Pamilyang Pilipino Program (4P's), a special project which is currently being implemented by the national government as a poverty reduction strategy provides cash grants to extremely poor households to improve their health, nutrition and education particularly of children aged 0-18;

WHEREAS, the objectives of this project are to provide cash assistance to the poor to alleviate their needs and to break the intergenerational poverty cycle through investments in human capital and addresses the 5 out of 8 Millennium Development Goals; 1.) Reducing extreme poverty and hunger; 2.) Achieving universal primary education; 3.) Reducing child mortality; 4.) Improving maternal health; and 5.) Promoting gender and equality and empowering woman;

WHEREAS, the convergence strategy seeks to enhance the DSWD's role to generate more sustainable and tangible impact on poverty reduction by harmonizing the Pantawid Pamilya Kapit-Bisig Laban sa Kahirapan-Comprehensive and Integrated Delivery of Social Services (KALAHI-CIDDS) and soon to open in our Region and Sustainable Livelihood, three of the DSWD's core social protection programs;

WHEREAS, there is an imperative need for the reorganization and designation of the members of the Municipal Advisory Committee and Municipal Interagency Committee to implement the 4Ps and the convergence strategy program in the Municipality of Solsona, Ilocos Norte due to the change of local officials brought about by the national and local election last May 13, 2019;

NOW THEREFORE, I, JOSEPH E. DE LARA, Municipal Mayor of Solsona, Ilocos Norte by virtue of the powers vested in me by law as the Local Chief Executive do hereby reorganize and designate the following members of the Municipal Advisory Council that will help in the implementation of this program, to wit:

Section 2. FUNCTION: The Municipal Advisory Committee and Municipal Interagency Committee (MAC and MIAC) shall perform the following actions:

- 1. Enhance national ownership and promote joint efforts with partner agencies and local implementers;
- Ensure the availability of supplies on health nutrition and education as well as to provide the necessary support services to meet the conditionalities for the access of the program as well as to promote complementation with other stakeholders:
- Organize and strengthen interagency network to ensure convergence of services and serve as advisory group for the implementation of the program; and
- 4. Interagency convergence coordinating committee (Major implementers and stakeholders will be created at various levels to:
 - A. Provide policy directions; and
 - B. Facilitate the creation of environment conducive to convergence of interagency alleviation programs.

Section 3. EFFECTIVITY. This Executive Order shall take effect immediately and conduct the said meeting every last Thursday of the Month.
