### **EXECUTIVE ORDER NO. 041** **Series of 2019**

#### **REORGANIZING THE LOCAL HOUSING BOARD OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE**

**WHEREAS**, Section 9, Article XII of the 1987 Philippine Constitution provides that, "The State shall, by law, and for common good, undertake, in cooperation with the private sector, continuing program... land reform and decent housing model, make available at affordable cost decent housing and basic services for the underprivileged and homeless citizens in..... resettlement areas;

**WHEREAS**, the Local Government Code of 1991 likewise mandates Local Government Units with the responsibility to provide basic services and facilities to include programs and projects for low cost housing and mass dwellings;

**WHEREAS**, Republic Act No. 7279 also known as Urban Development and Housing Act, provides for the preparation of a comprehensive and continuing housing program, establish the mechanism for each implementation and for other purposes;

**WHEREAS**, there is a need to reorganize the Local Housing Board of Solsona, Ilocos Norte due to change of local officials and employees as a result of the local and national elections last May 13, 2019;

**NOW THEREFORE**, I, JOSEPH E. DE LARA, Municipal Mayor, Solsona, Ilocos Norte by virtue of the powers vested in me by law, hereby order the reorganization of the Local Housing Board of the Municipality of Solsona, Ilocos Norte, to wit:

**Section 1. Composition.** The Local Housing Board of Solsona, Ilocos Norte shall be composed of the following:

**Section 2. Duties and Functions:** The Local Housing Board shall have the following duties and functions:


1. Formulate the short, medium and long term shelter development plan of the Municipality in accordance and based on the development priorities of Municipal Development Plan;
2. Establish policies and implementing guidelines for the municipality's housing program in consonance with R.A. No. 7279;
3. Formulate policy guidelines on the overall rural development program, (i.e. basic services and facilities, social enterprises, security of land tenure, infrastructure, health, water and sanitation, solid waste disposal, disaster risk management directed to mitigation and adaption vis-à-vis climate change, education and others;
4. Monitor the implementation of the housing policies and programs of the municipality;
5. Obtain, establish and manage resources for the Municipality's housing program; and
6. Link and network with government agencies, bilateral organizations, non-government organizations/civil societies, and the private sectors involved in socialized housing programs and integrated social housing delivery under the framework of convergence of resources.

**Section 3. Repealing Clause.** All Executive Orders, Rules and Regulations and other Issuances or parts thereof inconsistent with this Executive Order are hereby repealed and modified.



**Section 5. EFFECTIVITY.** This Executive Order shall take effect immediately upon its approval.
