**EXECUTIVE ORDER NO. 043**  
**Series of 2020**

**CONSTITUTING TEAMS OF THE RESPONSIBLE PARENTHOOD AND REPRODUCTIVE HEALTH (RPRH) LAW OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE**

**WHEREAS**, President Rodrigo Roa Duterte has repeatedly declared as a national policy and priority strategy the intensified implementation of National Program on Population and National Planning (NPPF).

**WHEREAS**, In President's 10-Point Economic Agenda, he strategically and implicitly included the full implementation of the Responsible Parenthood and Reproductive Health (RPRH) Law to enable especially the poor couples to make informed choices on financial and family planning.

**WHEREAS**, The Philippine Development Plan (PDP) for 2017-2022 has likewise included the achievement of demographic dividend as a key strategy in harnessing the country's growth potential.

**WHEREAS**, During the 35<sup>th</sup> Cabinet Meeting (March 4, 2019), President Duterte and the members of the Cabinet further reiterated such priority program by approving and mandating relevant agencies in the aggressive and intensified implementation of the NPPF.

**NOW THEREFORE, I JOSEPH E. DE LARA**, by the powers vested in me by law as the Municipal Mayor of Solsona, Ilocos Norte, do hereby constitute the Local Implementing Teams of the RPRH Law of the Municipality of Solsona, Ilocos Norte, as follows:

**Section 1. Composition. The following shall compose the Local Implementing Teams of the Responsible Parenthood and Reproductive Health (RPRH) Law:**

**Section 2. Duties and Functions of the Local Implementing Teams of the Responsible Parenthood and Reproductive Health (RPRH) Law:**

1. The agenda of such meeting shall include, but not limited to the development and implementation of policies/programs/projects/activities (PPAS) relative to the promotion and fulfillment of Responsible Parenthood and Reproductive Health (RPRH) law specifically localizing the national program on population and family planning.
2. Meeting conducted shall be supported by Minutes of Meeting duly signed by the Secretariat Head, Notices of Meetings, Attendance Sheets and pictures.
3. Undertake information, education and advocacy campaign on RPRH to give prominence to the implementation of family planning in the country.
4. Conduct capacity-building programs for all stakeholders involved in the implementation of RPRH PPAs.
5. Provide services to all men and women regarding the programs and population and family planning.
6. Create and establish systems on effective coordination with the national agencies involved in the promotion and implementation of the RPRH.
7. Institute policies and programs to promote the welfare of men and women on RPRH programs aligned with the national thrusts.

**Section 3. Separability Clause.** All Executive Orders, Rules and Regulations and other Issuances or parts thereof inconsistent with this Executive Order are hereby repealed and modified.

**Section 4. Effectivity.** This Executive Order shall take effect immediately upon its approval.
