EXECUTIVE ORDER NO. 044 **Series of 2019**

REORGANIZING THE CLEAN & GREEN, PUBLIC SAFETY AND PEACE & ORDER TASK FORCE OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE

WHEREAS, the Municipal Government of Solsona desires to fully implement the Clean & Green Program and Public Safety, Peace and Order activities by inculcating in the minds of the people self-discipline, orderliness and safety;

WHEREAS, full, continuous, fair and judicious implementation of relative laws and ordinances that have direct concern with the clean and green program and peace and order activities could contribute to the success of this undertaking;

WHEREAS, the reorganization of a Clean & Green, Public Safety and Peace & Order Task Force is needed in order to have a team to oversee, administer and enforce the Clean and Green Program and Public Safety, Peace and Order campaign in the municipality;

WHEREAS, there is a need to reorganize the Clean & Green, Public Safety and Peace & Order Task Force of Solsona, Ilocos Norte due to change of local officials and employees as a result of the local and national elections last May 13, 2019;

NOW THEREFORE, I, JOSEPH E. DE LARA, Municipal Mayor, Solsona, Ilocos Norte by virtue of the powers vested in me by law, hereby order the reorganization of the Clean & Green, Public Safety and Peace & Order Task Force of the Municipality of Solsona, Ilocos Norte, to wit:

Section 1. Composition. The Clean & Green, Public Safety and Peace & Order Task Force of Solsona, Ilocos Norte shall be composed of the following:

Section 2. Duties and Functions: The task force shall have the following duties and functions:

1. Administer the cleaning, greening, public safety, peace and order activities in the municipality;
2. Adopt legislative measures that will enhance and develop the implementation of the Clean & Green, Public Safety and Peace & Order campaign;
3. Act on legal matters pertaining to the administration and enforcement of the Laws and Ordinances of the municipality;
4. Conduct Information Dissemination;
5. Collect fines/penalties imposed on violators;

6. Administer and enforce all relative Laws and Ordinances that are to be considered;
7. Conduct counseling to all violators as deemed necessary or as provided for; and
8. Monitor and evaluate the conduct of the Task Force.

Section 3. Repealing Clause. All Executive Orders, Rules, Regulations and other Issuances or parts thereof inconsistent with this Executive Order are hereby repealed and modified.

Section 5. EFFECTIVITY. This Executive Order shall take effect immediately upon its approval.
