EXECUTIVE ORDER NO. 045 Series of 2019

REORGANIZING THE MUNICIPAL COUNCIL FOR CULTURE AND THE ARTS OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE

WHEREAS, Section 16, Title I, Book I of Republic Act No. 7160, otherwise known as "An Act Providing for A Local Government Code of 1991" provides that the Local Government Unit shall exercise the powers expressly granted and those necessary and incidental to carry out the general welfare specially to ensure and support, among other things, the preservation and enrichment of culture;

WHEREAS, Paragraph (xvi), Section 447, Title II, Book III of Republic Act No. 7160, provides for the establishment of a municipal council whose purpose is the promotion of culture and the arts, coordinate with government agencies and non-government organizations and, subject to the availability of funds, appropriate funds for the support and development of the same;

WHEREAS, DILG Memorandum Circular No. 2002-81 mandates the creation of council for the Culture and the Arts;

WHEREAS, there is a need to reorganize the Council for Culture and the Arts of Solsona, Ilocos Norte due to the change of local officials as a result of the local and national elections last May 13, 2019;

NOW THEREFORE, I, JOSEPH E. DE LARA, Municipal Mayor, Solsona, Ilocos Norte by virtue of the powers vested in me by law, do hereby reorganize the Council for Culture and the Arts of the Municipality of Solsona, Ilocos Norte, as follows:

Section 1. Composition. The Council for Culture and the Arts of Solsona, Ilocos Norte shall be composed of the following:

Section 2. Duties and Functions: The Municipal Council for Culture and the Arts shall have the following duties and functions:

1. Prepare an annual plan on culture and the arts consistent to the Medium Term Philippine Development Plan for Culture and the Arts, to be integrated in the Local Development Plan;
2. Formulate programs and recommendations and conservations of the Local Culture and Artistic talent;
3. Ensure the protection, preservation and conservation of the local cultural and historical heritage;
4. In coordination with various sectors, conduct cultural events such as: cultural festivals, competition, lectures, seminars, set up exhibits during fiestas and other related activities;
5. Encourage the development of local cultural industries;
6. Conduct periodic consultations with all stakeholders to identify grassroots-based cultural concerns, issues and agenda; and
7. Conduct periodic inventory of local cultural objects and sites in coordination with the National Commission for Culture and the Arts.

Section 3. Repealing Clause. All Executive Orders, Rules and Regulations and other Issuances or parts thereof inconsistent with this Executive Order are hereby repealed and modified.

Section 4. Effectivity. This Executive Order shall take effect immediately upon its approval.
