### **EXECUTIVE ORDER NO. 047 Series of 2019**

#### **REORGANIZING THE MUNICIPAL PHYSICAL FITNESS AND SPORTS DEVELOPMENT COUNCIL OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE**

**WHEREAS**, the Local Government Code of 1991 provides that local government units shall, within their territorial jurisdictions, promote health, safety, improve public morals, maintain peace and order and preserve the comfort and convenience of its inhabitants;

**WHEREAS**, DILG Memorandum Circular No. 2003-33 mandates local government units to organize/reactivate Physical Fitness and Sports Development Councils;

**WHEREAS**, Section 17 par. (b) (2) (vii), Title I of Book I of R.A. No. 7160, provides that Local Government Unit shall likewise such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities for municipal buildings, cultural centers, public parks including freedom parks, playgrounds, and sports facilities and equipment, and other similar facilities.

**WHEREAS**, there is a need to re-organize the Municipal Physical Fitness and Sports Development Council of Solsona, Ilocos Norte due to the change of local officials brought about by the local and national elections last May 13, 2019;

**NOW THEREFORE, I, JOSEPH E. DE LARA**, by the powers vested in me by law as the Mayor of Solsona, Ilocos Norte, do hereby organize the Municipal Physical Fitness and Sports Development Council of the municipality of Solsona, Ilocos Norte:

**Section 1. Re-organization and Composition.** The following shall compose the Municipal Fitness and Sports Development Council of the municipality of Solsona, Ilocos Norte:

**Section 2. Duties and Functions.** The Municipal Physical Fitness and Sports Development Council shall have the following duties and functions:

- a. Formulate a blueprint for the short, medium and long-term plan for the sectoral sports based on the national Policy and Program of "SPORTS FOR ALL";
- b. Conduct local sports summits in consultation with other public and private entities concerned;
- c. Oversee and ensure the implementation of the physical fitness and sports program and activities in the municipality;
- d. Disseminate proper information on the national policy and program, including their local programs to encourage the active participation of their constituents on physical fitness and sports activities;
- e. Assist in the identification, recruitment and training of gifted and talented athletes;
- f. Formulate programs to address the development of grass-roots talents on various fields of sports that can compete at national level or internationally; and
- g. Perform other functions deemed necessary to promote and implement the National Policy Program.

**Section 4. Secretariat.** There shall be constituted Secretariat responsible for providing technical and administrative support, documenting proceedings, preparing reports and providing for such other assistance as may be required by the Council. The Secretariat of the MPFSDC shall be the following:

**Section 5. Repealing Clause.** All Executive Orders, Rules and Regulations and other issuances or parts thereof inconsistent with this Executive Order are hereby repealed and modified.

**Section 6. Effectivity.** This Executive Order shall take effect immediately upon its approval.
