EXECUTIVE ORDER NO. 050 Series of 2019

REORGANIZATION OF THE TEAM REGULATING THE MANUFACTURE, SALE AND USE OF FIRECRACKERS AND OTHER PYROTECHNIC DEVICES IN THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE

WHEREAS, Republic Act No. 7183 contains illustrative lists of what comprises firecrackers and other pyrotechnic devices, and provides for the regulation and control of their manufacture, sale, distribution and use consistent with, and in furtherance of public safety, order and national security, as well as the enhancement of the cultural traditions;

WHEREAS, Executive Order No. 28 dated June 20, 2017 of President Rodrigo R. Duterte provides for the regulation and control of the use of Firecrackers and other Pyrotechnic Devices;

WHEREAS, said Executive Order No. 28 series of 2017 of President Rodrigo R. Duterte authorized the Local Chief Executive to promulgate the necessary rules and regulations on firecrackers and other pyrotechnic devices within their territorial jurisdiction in conformity with the national standards, rules and regulations;

WHEREAS, the Municipality of Solsona, Ilocos Norte gives priority in safeguarding the life and health of the towns people by regulating the manufacture, sale, use and distribution of firecrackers in the municipality to individuals or groups without having complied to the provisions of this Order;

WHEREAS, there is a need to reorganize the Team regulating the manufacture, sale and use of firecrackers and other pyrotechnic devices due to the change of local officials as a result of the local and national elections last May 13, 2019;

NOW THEREFORE, I, JOSEPH E. DE LARA, Municipal Mayor, Solsona, Ilocos Norte by virtue of the powers vested in me by law, hereby order the reorganization of the Team regulating the manufacture, sale and use of firecrackers and other pyrotechnic devices of Solsona, Ilocos Norte, to wit:

Section 1. Composition. The Team regulating the manufacture, sale and use of firecrackers and other pyrotechnic devices of Solsona, Ilocos Norte shall be composed of the following:

Section 2. Duties and Functions: The Team to regulate the manufacture, sale and use of firecrackers and other Pyrotechnic Devices in the municipality shall have the following duties and functions:

1. The Team shall have the power to regulate the manufacture, sale and distribution of firecrackers and other pyrotechnic devices in the Municipality of Solsona, Ilocos Norte;
2. To monitor and confiscate sales, distribution and use of firecrackers and other pyrotechnic devices not allowed by law and outside the designated fireworks display;
3. The team shall come up with procedures and guidelines in the conduct of community fireworks display in order to minimize the risk of injuries and casualties;
4. The action team as far as practicable shall come up with an area where to carry out or perform the community fireworks display;
5. The team shall have the power to confiscate and destroy seized firecrackers which is prohibited to be sold in the municipality and seek the assistance of the Philippine National Police (PNP) if necessary; and
6. The team shall come up with list of firecrackers which are prohibited to be sold, distributed and used in the municipality.

Section 3. The Team shall provide persons granted with Special Permit to sell and use firecrackers and pyrotechnic devices list which are prohibited by law.

Section 4. Repealing Clause. Any law, orders and other administrative issuances inconsistent with this Executive Order are hereby repealed or modified accordingly.

Section 5. EFFECTIVITY. This Executive Order shall take effect immediately after its approval.
