CREATING THE CONTRACT TERMINATION REVIEW COMMITTEE OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE

WHEREAS; Republic Act No. 9184 (R.A. 9184), otherwise known as "Government Procurement Reform Act", and its Implementing Rules and Regulations Part A (IRR-A) took effect on January 26, 2003 and October 8, 2003 respectively;

WHEREAS, the Government Procurement Policy Board (GPPB) shall protect the national interest in all matters affecting public procurement and shall formulate public procurement policies, rules and regulations, and amend, whenever necessary under Section 65 of R.A. 9184;

WHEREAS, in line with the said mandate, the GPPB formulated guidelines on termination of contracts in relation to procurement contract entered into by the government, GPPB Resolution No. 018-2004 dated December 22, 2004, Annex "A";

WHEREAS, there is a need to create a Contract Termination Review Committee (CTRC) of the municipality of Solsona, Ilocos Norte to assist the Head of Procuring Entity (HOPE) in the discharge of his function under the guidelines;

NOW THEREFORE, I, JOSEPH E. DE LARA, Municipal mayor, Solsona, Ilocos Norte by virtue of the powers vested in me by law, hereby order the creation of a Contract Termination Review Committee, as follows:

Section 1. Creating a Contract Termination Review Committee (CTRC) and Providing for its Composition. A committee in the Municipal Government of Solsona, Ilocos Norte to be known as the "Contract Termination Review Committee (CTRC) is hereby created to be composed of the following:

Chairperson	- MRS. DIVINA G. DOMINGO	- Municipal Accountant
Vice Chairperson	- MRS. CHRISTINA E. DELOS SANTOS	- Municipal Treasurer
Members	- MR. ALFONSO JEZIEL M. DE LOS REYES-	Private Secretary II

Section 2. Duties and Functions. The Contract Termination Review Committee (CTRC) shall have the following duties and functions:

1. Verify reports submitted by the Implementing Unit to the HOPE setting forth its findings as to existence of grounds or causes for termination and explicitly stating its recommendation for the issuance of a Notice to terminate;
2. Determine the existence of conditions that make Project Implementation economically, financially or technically impractical and/or unnecessary, such as, but not limited to, fortuitous event(s) or changes in law and national government policies;
3. Follow the Guidelines on Termination of Contracts (GPPB Resolution No. 018-2004, Annex "A"); and
4. Perform such other functions as necessary in carrying out the mandate of said Committee.

Section 3. Repealing Clause. All other orders, rules, regulations and issuances, or parts thereof, which are inconsistent with this Executive Order, are hereby repealed, amended or modified accordingly.

Section 4. Effectivity. This Executive Order shall take effect immediately upon its approval.
