EXECUTIVE ORDER NO. 056 Series of 2019

REORGANIZING THE MUNICIPAL AGRICULTURAL AND FISHERY COUNCIL OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE

WHEREAS, Section 2 of Republic Act No. 8435 of the Agriculture and Fisheries Modernization Act operationalizes the policy of the state, to enable those who belong to the agriculture and fisheries sectors to participate and share in the fruits of development and growth in a manner that utilize the nations resources;

WHEREAS, Republic Act No. 9418 also known and cited as the Volunteer Act of 2007 provides that it shall be the policy of the state to promote the participation of the various sectors of the Filipino society... in public and civic affairs, adopt and strengthen the practice of volunteerism as a strategy in order to attain national development;

WHEREAS, the Local Government Code of 1991 shall promote the operation of people and non-government organization to become active partners in the pursuit of Local Economy;

WHEREAS, DILG MC No. 97-271 and 98-200 and reiterated in DILG MC 200-63, the Chairman of the MAFC shall be a member of the LDC, and serves as agriculture and fishery consultative development of the LDC;

WHEREAS, the Municipality of Solsona, Ilocos Norte fully supports the effective participation of volunteers in public service and provides for the development of volunteer organizations, however these entities shall be in one way or another be governed by existing laws, policies and protocols;

WHEREAS, there is a need to reorganize the Municipal Agricultural and Fishery Council of Solsona, Ilocos Norte due to change of local officials and employees as a result of the local and national elections last May 13, 2019;

NOW THEREFORE, I, JOSEPH E. DE LARA, Municipal Mayor of the Municipality of Solsona, Province of Ilocos Norte, by virtue of the powers vested in me by law, hereby order the reorganization of the Agricultural and Fishery Council of the Municipality of Solsona, Ilocos Norte.

Section 1. **Reorganization and Composition.** The following shall compose the Municipal Agricultural and Fishery Council:

Section 2. **Duties and Functions.** The Municipal Agricultural and Fisheries Council shall have the following duties and functions:

1. Serves as the focal agency in private – public partnership policy development relative to agriculture;
2. Serves as consultative/feedback mechanism on the policies, plans and programs relative to agriculture;
3. Participate in the implementation and/or coordination of local agricultural and fisheries programs and projects;
4. Provide assistance in the conduct of monitoring of agriculture and fishery programs and projects;
5. Assist the Municipal Agriculture in the conduct of basic research on crops, livestock and fisheries diseases and pest and other agricultural matters which will maximize productivity;
6. Assist the MA in the establishment and extension services of demonstration farms relative to agriculture;

7. Recommend to the MA all other matters related to agriculture and aquaculture which will improve the livelihood and living conditions of farmers and fisher folks;
8. Assists enforcement of rule and regulations relating to agriculture and aquaculture; and
9. Perform such other duties and functions as maybe prescribed by Agriculture Laws, Policies and Ordinances.

Section 3. Secretariat.

There shall be a constituted secretariat to be headed by the Municipal Agriculturist who will be responsible for providing technical and administrative support, documentary proceedings and providing other assistance as maybe required by the council.

Section 4. Repealing Clause. All Executive Orders, Rules and Regulations and other Issuances or parts thereof inconsistent with this Executive Order are hereby repealed and modified.

Section 3. **Effectivity.** This Executive Order shall take effect immediately upon its approval.
