EXECUTIVE ORDER NO. 059 Series of 2019

DESIGNATION OF MS. AILEEN JOYCE C. PASCUAL AS HEAD, OFFICE OF PERSONS WITH DISABILITIES (OPDA) OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE

WHEREAS, the Office of Persons with Disabilities Affairs (OPDA) of Solsona, Ilocos Norte was created by virtue of Municipal Ordinance No. 2005-548 enacted last May 9, 2005;

WHEREAS, there is a need to implement programs and projects and provide services to ensure rehabilitation, self-development and self-reliance of persons with disabilities to comply to the provisions of Sections 2 and 13 of the Constitution;

WHEREAS, R.A. 7277, otherwise known as the Magna Carta for Disabled Persons as well as R.A. 7160 otherwise known as the Local Government Code of 1991 mandate Local Government Units to implement programs and services to ensure the full participation of PWDs in all aspect of community life;

WHEREAS, there is a need to designate a head of the Office of Persons with Disabilities (OPDA) of the municipality to take charge of all concerns of Persons with Disabilities of Solsona, Ilocos Norte;

NOW THEREFORE, I, JOSEPH E. DE LARA, Municipal Mayor, Solsona, Ilocos Norte by virtue of the powers vested in me by law, do hereby order that:

SECTION I. Designation of Head of Persons with Disabilities Affairs (OPDA) of Ms. Aileen Joyce C. Pascual of Barangay Nalasin, Solsona, Ilocos Norte as Head of the Office of Persons with Disabilities Affairs of Solsona, Ilocos Norte.

SECTION II. Duties and Responsibilities. The Head of OPDA shall perform the following duties and responsibilities as stated:

1. Conduct needs assessment of PWDs of the municipality;
2. Conduct planning, monitoring and evaluation of programs, projects and activities of PWDs of Solsona, Ilocos Norte; and

3. Perform other duties and functions as may be authorized by concerned authorities.

Section III. Separability Clause. All Executive Orders, Rules and Regulations and other issuances of parts thereof inconsistent with this Executive Order are hereby repealed and modified.

Section IV. Effectivity. This Executive Order shall take effect immediately upon its approval.
