**AMENDING SECTION 1 EXECUTIVE ORDER NO. 005, SERIES OF 2019,
REORGANIZING THE MUNICIPAL SCHOOL BOARD (MSB) OF THE MUNICIPALITY
OF SOLSONA, ILOCOS NORTE**

WHEREAS, there is already an existing Municipal School Board (MSB) of the Municipality of Solsona pursuant to Republic Act No. 7160 otherwise known as the Local Government Code of 1991;

WHEREAS, the said Municipal School Board (MSB) was last reorganized on July 12, 2019, per Executive Order No. 005, s. 2019 signed by the Local Chief Executive;

WHEREAS, Republic Act No. 7160 otherwise known as the Local Government Code of 1991 prescribes the involvement of Civil Society Organizations (CSOs) in the Municipal School Board;

WHEREAS, in order to conform with existing policy guidelines, there is a need to amend the composition of the Municipal School Board (MSB) of Solsona, Ilocos Norte;

NOW THEREFORE, by virtue of the power vested in me by law as the Municipal Mayor of Solsona, Ilocos Norte, do hereby order the amendment of Section 1 of Executive Order No. 005, Series of 2019 of the Municipal School Board (MSB) as follows:
