**EXECUTIVE ORDER NO. 069**

**AMENDING SECTIONS 1 AND 2, EXECUTIVE ORDER NO. 029, SERIES OF 2019,  
REORGANIZING THE MUNICIPAL PEACE AND ORDER COUNCIL (MPOC) OF THE  
MUNICIPALITY OF SOLSONA, ILOCOS NORTE**

**WHEREAS**, there is already an existing Municipal Peace and Order Council (MPOC) of the Municipality of Solsona pursuant to Republic Act No. 7160 otherwise known as the Local Government Code of 1991;

**WHEREAS**, the said Municipal Peace and Order Council (MPOC) was last reorganized on August 14, 2019, per Executive Order No. 029, s. 2019 signed by the Local Chief Executive;

**WHEREAS**, Republic Act No. 7160 otherwise known as the Local Government Code of 1991 prescribes the involvement of Civil Society Organizations (CSOs) in the Municipal Peace and Order Council (MPOC);

**WHEREAS**, in order to conform with existing policy guidelines, there is a need to amend the composition of the Municipal Peace and Order Council (MPOC) of Solsona, Ilocos Norte;
