IMPLEMENTING A TEMPORARY TOTAL BAN OF BACKYARD SLAUGHTER UNTILL SUCH TIME THAT AFRICAN SWINE FEVER IS TOTALLY CONTROLLED

WHEREAS, the General Welfare Clause of the Local Government code of 1991 provides that every local government shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate or incidental for each efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, The Sangguniang Bayan passed RESOLUTION NO. 2019-285 titled "*Encouraging the Local Chief Executive HON. JOSEPH E. DE LARA to issue an executive order for the total ban of backyard slaughter until such time that the African Swine Fever is totally controlled*";

WHEREAS, The DILG Field Officers were directed to enjoin all Local Government Units within their respective areas of jurisdiction to implement measures to contain the outbreak of the ASF and to ensure public safety on consumption of pork meat products;

WHEREAS, The Governor issued special order NO. 19-2019 S 2019 to actively involved the prevention of the entry and spread of ASF diseases in the province;

NOW THEREFORE, I, JOSEPH E. DE LARA, Municipal Mayor of Solsona, Ilocos Norte do hereby order a temporary total ban of backyard slaughter until such time ASF is totally controlled.

Further, to ensure safety of our constituents and our swine industry, the MAO meat inspection, and sanitary office are hereby directed to strengthen the biosafety, hygiene, and sanitation standard in slaughterhouses/ abattoirs and public market.

This order shall take effect immediately.
