MUNICIPAL ORDINANCE NO. 2001-534

AN ORDINANCE CREATING THE PHILHEALTH CAPITATION FUND FROM THE PROCEEDS OF THE OUT PATIENT BENEFIT PACKAGE TO BE PROVIDED BY THE PHILHEALTH INSURANCE CORPORATION (PHILHEALTH) FOR QUALIFIED INDIGENT FAMILIES IN THE MUNICIPALITY OF SOLSONA UNDER THE INDIGENT SECTOR COMPONENT OF THE NATIONAL HEALTH INSURANCE PROGRAM (NHIP).

WHEREAS, in pursuit of these constitutional mandates, Congress has mandated the implementation of the indigent sector component of the National Health Insurance Program (NHIP) of the Medicare Para Sa Masa;

WHEREAS, indigent families in Solsona has been burdened to seek medical assistance because of a financial problem;

WHEREAS, it is one of the priority programs of our government to look for the benefit of the indigent families to give assistance for their better health services;

NOW THEREFORE, on motion of Hon. Zamuel F. Balantac, duly seconded by Hon. Bob G. Sacro, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - PHILHEALTH Insurance shall be given exclusively for indigent families;

Section 2 - PHILHEALTH Insurance shall include payment of out patient services;

Section 3 - This Ordinance shall take effect upon its approval;




