MUNICIPAL ORDINANCE NO. 100

AN ORDINANCE AUTHORIZING THE LOCAL CHIEF EXECUTIVE,  
MAYOR JOSEPH E. DE LARA TO EXECUTE AND SIGN ON BEHALF  
OF THE MUNICIPAL GOVERNMENT THE DEEDS OF TRANSFER OF  
ONE (1) UNIT OF DUMP TRUCK.

WHEREAS, pursuant to the provisions of Article 87  
(b) (vi), the Sangguniang Bayan is empowered to grant authori-  
zation to represent the municipality in all its business tran-  
sactions and sign on its behalf all bonds, contracts and obli-  
gations and such other documents made;

WHEREFORE, upon motion of Hon. Rogerio E. Teodoro,  
duly seconded by Hon. Jovencio M. Pascua and by virtue of the  
power vested upon the Sangguniang Bayan and pursuant to the  
aforecited provisions of Republic Act 7160, be it ordained that:

Section 1 - The Local Chief Executive, Mayor Joseph E.  
de Lara is hereby given the authority to execute and sign on  
behalf of the Municipal Government the Deeds of Transfer of one  
(1) unit of dump truck;

Section 2 - This Ordinance shall take effect upon app-  
roval of this Ordinance;
