MUNICIPAL ORDINANCE NO. 101

SIGN PERMITS, CLEARANCES, MARRIAGE CONTRACTS,  
ORDINANCES SIDE BY SIDE WITH THE MUNICIPAL  
MAYOR IN THE OBSERVANCE OF PROCLAMATION NO.  
99 AND PURSUANT TO RULE XXVIII, ART. 208 OF  
THE IRR OF RA 7160.

WHEREAS, pursuant to Proclamation No. 99  
every second week of December and every year there  
after was declared as the Linggo Ng Kabataan;

WHEREAS, in order that Rule XXVIII, Art. 208  
of the IRR of RA 7160 will be more significant, mea-  
ningful and memorable, in the observance of the Linggo  
Ng Kabataan, be it

ORDAINED, by the Sangguniang Bayan of Solsona,  
Ilocos Norte, that

Section 1 - The Junior Municipal Mayor is  
hereby authorized to sign permits, clearances, Ordinances  
and Marriage contracts side by side with the Municipal  
Mayor;

Section 2 - This Ordinance shall take effect  
immediately and shall expire on the last day of his  
term.
