MUNICIPAL ORDINANCE NO. 102

AN ORDINANCE IMPOSING/REGULATING THE FARE OF  
TRICYCLE FOR HIRE OPERATING WITHIN THE JURIS-  
DICTION OF THE MUNICIPALITY OF SOLSONA, ILOCOS  
NORTE.

WHEREAS, pursuant to Local Government Code (RA  
No. 7160) the Sangguniang Bayan has the sole power/authority  
to impose/regulate the fare of tricycle for hire operating  
within the territorial limits of the municipality;

WHEREAS, the fare has been established at a level  
that will provide the operators reasonable return of profit  
and still be afforded by general riding public;

WHEREFORE, on motion of Hon. Antolin D. Refani and  
duly seconded by Hon. Gervacio B. Vicente and Hon. Luis B.  
Ganal, be it

ORDAINED, by the Sangguniang Bayan of Solsona,  
Ilocos Norte, that:

Section 1 - All operators/drivers of tricycles for  
hire should follow strictly the prescribed fare to all the  
different route/zones within the territorial limits of  
Solsona, Ilocos Norte;

Section 2 - The fares being imposed are to wit  
and hereto attached;

Section 3 - The tariff fare be posted inside the  
tricycle;

Section 4 - The driver or the riding public who  
will not comply with the prescribed fare at the different  
routes will be penalized by paying FIFTY PESOS (₱50.00)  
or be suspended from operating for one (1) month or both  
at the discretion of the court;

Section 5 - This Ordinance shall take effect ten  
(10) days after a copy of it is posted on Bulletin Board  
and other conspicuous places and be published to local  
newspaper in circulation;




