MUNICIPAL ORDINANCE NO. 119

AN ORDINANCE AUTHORIZING PARKING FEE COLLECTOR TO BE ENTITLED WITH MEAL AND TRANSPORTATION ALLOWANCES EFFECTIVE AUGUST 1, 1993 TO COVER FOR HER SERVICES RENDERED DURING SATURDAYS, SUNDAYS AND HOLIDAYS ONLY.

WHEREAS, in conformity with COA Circular No. 91-368, Section 418-b-2, dated December 19, 1991, Officials and Employees who have rendered at least three hours of overtime from 9:00 A.M. to 12:00 noon and from 1:00 P.M. to 4:00 P.M. are entitled to a meal and transportation allowances;

WHEREAS, Mrs. Pergentina Dichoso is designated as Parking Fee Collector of PUJ Jeeps and tricycles for hire within the jurisdiction of the municipality of Solsona, Ilocos Norte;

WHEREAS, said Collector is rendering services on Saturdays, Sundays and Holidays and incur actual expenses for fare from home to Office and vice-versa;

WHEREAS, the basis for computation is the number of Saturdays per month multiplied by P17.00 as meal and transportation allowances and the number of Sundays per month multiplied by P27.00 equivalent to her additional compensation;

WHEREFORE, on motion of Hon. Antelin D. Refani, duly seconded by Hon. Jovencio M. Pascua, be it ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - The Parking Fee Collector is authorized to collect her meal and transportation allowances equivalent to her extra services; bills amounting to P400.00 per month;

Section 2 - This Ordinance shall take effect retro-active from the time Mrs. Pergentina Dichoso rendered her services as Parking Fee Collector;
