MUNICIPAL ORDINANCE NO. 128

AN ORDINANCE AUTHORIZING THE MUNICIPAL TREASURER
TO RECEIVE VOLUNTARY CONTRIBUTIONS FROM REAL
PROPERTY TAX PAYERS WHOSE RESIDENTIAL HOUSES ARE
EXEMPTED FROM THEIR REAL PROPERTY TAXES PURSUANT
TO THE PROVISIONS OF SECTION 218 (b) of R.A. 7160.

WHEREAS, R.A. 7160 particularly Section 218 (b)
mandates that Fair Market Value of buildings and other
structure related thereof whose fair market value falls
ONE HUNDRED SEVENTY FIVE THOUSAND PESOS (P175,000.00) and
below are exempted to pay their Real Property Tax;

WHEREAS, some Real Property Tax Payers want to pay
said taxes though they are exempted from paying due to the
fact that they want to establish ownership/possession and
for other legal purposes;

WHEREFORE, by virtue of the power vested upon the
Sangguniang Bayan and upon motion of Hon. Roderic Teodoro,
duly seconded by Hon. Gervacio Vicente, be it Ordained that:

Section 1 - The Municipal Treasurer is hereby granted
authority to receive voluntary contributions from Real Property
Tax Payers whose residential houses are exempted from paying
Real Property Taxes;

Section 2 - This Ordinance shall take effect immediate-
ly upon its approval;


