MUNICIPAL ORDINANCE NO. 142

ORDINANCE PROHIBITING LAVISH AND EXPENSIVE CONDUCT OF GRADUATION EXERCISES AND OTHER OCCASSIONS IN THE ELEMENTARY AND SECONDARY PUBLIC SCHOOLS WITHIN THE JURISDICTION OF SOLSONA, ILOCOS NORTE AND PROVIDING PENALTIES THEREOF.

WHEREAS, parents of school pupils and students are financially hard up and burdened in bringing their children to school;

WHEREAS, parents will spend less through simple conduct of programs;

WHEREAS, austerity is the need of the time;

WHEREFORE, on motion of Hon. Luis B. Ganal, duly seconded by Hon. Antolin D. Refani, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - Head of Schools and Teachers should observe austerity in the conduct of closing exercises and other occasions;

Section 2 - This should be in accordance with the Code of Public Safety;

Section 3 - Any violation of this Ordinance be punished by a fine of not less than FIVE HUNDRED PESOS (P500.00) but not more than ONE THOUSAND PESOS (P1,000.00) or an imprisonment of not less than one month and not more than two months or both at the discretion of the court;

Section 4 - This Ordinance shall take effect after a lapse of ten days after posting in three conspicuous places and after publication in a newspaper of local circulation;

Voting on the foregoing measure, as follows:

In favor - Hons. Batara, Teodoro, Vicente, Agulay, Ganal, Estavillo, Refani, Edison de Lara and Jonathan de Lara;

Against - None

Copies of this Ordinance be furnished the Schools Division Superintendent, Ilocos Norte, Ilocos Norte, the District Supervisor, Solsona, Ilocos Norte, the Principal, Solsona National High School and the Sangguniang Panalawigan, Laoag City for their information and consideration;
