MUNICIPAL ORDINANCE NO. 145

ORDINANCE LIMITING THE NUMBER OF AWARDS GIVEN TO  
HONOR PUPILS AND STUDENTS FOR AN EXCELLENCE OBTAINED  
IN THE ELEMENTARY AND SECONDARY LEVELS AND PROVIDING  
PENALTIES THEREOF.

WHEREAS, it has been observed that honor pupils and  
students received more than one award for an excellence obtained;

WHEREAS, some pupils and students who obtained lower  
honors received more awards than those of higher honors;

WHEREFORE, on motion of Hon. Luis B. Ganal, duly seconded  
by Hon. Rogerio E. Teodoro, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos  
Norte, that:

Section 1 - Only one award be accorded to honor pupils  
and students for an excellence obtained;

Section 2 - Awards given to honor pupils and students  
be in accordance to the honor obtained;

Section 3 - Any violation of this Ordinance be punished  
by a fine of not less than ONE HUNDRED PESOS (P100.00) but not more  
than FIVE HUNDRED PESOS (P500.00) or an imprisonment of five (5)  
days but not more than ten (10) days or both at the discretion of  
the court;

Section 4 - This Ordinance shall take effect after a lapse  
of three weeks and after posting in three conspicuous places and  
after publication in a newspaper of local circulation;

Voting on the foregoing measure, as follows:

Infavor - Hons. Batara, Teodoro, Vicente, Pascua, Ganal,  
Agulay, Refani and Edison de Lara;

Against - None

tor, DECS, Region I, San Fernando, La Union, the Schools Division  
Superintendent, Division of Ilocos Norte, the District Supervisor,  
Solsona District and the Sangguniang Panlalawigan, Laoag City, for
