MUNICIPAL ORDINANCE NO. 146

AN ORDINANCE REQUIRING OWNERS OF BUSINESS ESTABLISHMENTS WITHIN THE JURISDICTION OF SOLSONA, ILOCOS NORTE TO HAVE TRASH CANS/TRASH BOXES INFRONT OF THEIR BUSINESS ESTABLISHMENTS AND PROVIDING PENALTIES THEREOF.

WHEREAS, pursuant to the Memorandum of the President, dated October 19, 1993, "Directive on Solid Waste Management", the Municipal Mayor will assume the responsibility for efficient collection and disposal of garbage;

WHEREAS, improper disposal of garbage greatly affects the cleanliness and attractiveness of the municipality;

WHEREAS, clean and beautiful surroundings promote better health and happy life;

WHEREFORE, on motion of Hon. Luis B. Canal, duly seconded by Hon. Gervacio Vicente and Hon. Edison de Lara, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - Owners of business establishments within the jurisdiction of Solsona are required to have trash cans/trash boxes in front of their business establishments;

Section 2 - Any violation of this Ordinance be punished by a fine of not less than FIVE HUNDRED PESOS (P500.00) but not more than ONE THOUSAND PESOS (P1,000.00) or an imprisonment of not less than five (5) days but not more than ten (10) days or both at the discretion of the Court;

Section 3 - This Ordinance shall take effect after a lapse of three (3) weeks posting in three (3) conspicuous places and after publication in any newspaper of local circulation;

Voting on the foregoing measure, as follows:

In favor - Hons. Batara, Teodoro, Vicente, Pascua, Canal, Agulay, Refani and de Lara;

Against - None

Copies of this Ordinance shall be furnished the Sangguniang Panlalawigan, Laoag City, for their information and consideration;
