MUNICIPAL ORDINANCE NO. 148

AN ORDINANCE PROHIBITING THE DUMPING OF GARBAGES ALONG THE TINA AND GASGAS RIVERS, NATIONAL ROADS, PROVINCIAL ROADS, MUNICIPAL STREETS, BARANGAY ROADS AND CREEKS WITHIN THE JURISDICTION OF SOLSONA, ILOCOS NORTE AND PROVIDING PENALTIES THEREOF.

WHEREAS, it has been observed that garbages are scattered everywhere particularly along the Tina and Gasgas Rivers;

WHEREAS, cleanliness is one of the thrusts of the Municipal Government of Solsona so it finds the passage of this Ordinance imperative;

WHEREAS, the passage of this Ordinance strongly supports the program of the President of the Philippines on the newly launched search for the cleanest and greenest Municipality and Province;

WHEREFORE, on motion of Hon. Gervacio B. Vicente duly seconded by Hon. Henry A. Batara and Hon. Rogerio Teodoro, be it

ORDAINED, by the Sangguniang Bayan, that:

Section 1 - The dumping of garbages along the Tina and Gasgas Rivers, National Roads, Provincial Roads, Municipal Streets, Barangay Roads and Creeks within the jurisdiction of Solsona, Ilocos Norte is hereby prohibited;

Section 2 - Anybody who violates this Ordinance shall be punished by a fine of not less than ONE THOUSAND PESOS (P1,000.00) but not more than TWO THOUSAND PESOS (P2,000.00) or imprisonment of not less than three (3) months but not more than six (6) months or both at the discretion of the court;

Voting on the foregoing measure, as follows:

Infavor - Hons. Batara, Teodoro, Vicente, Pascua, Canal, Agulay, Refani and Edison de Lara;

Against - None


This Ordinance shall take effect three weeks after it is posted on the bulletin board located at the Municipal Hall and other conspicuous places and after publication in a newspaper of local circulation;

Copies of this Ordinance be furnished to all concerned for their information;
