MUNICIPAL ORDINANCE NO. 154

**AN ORDINANCE PROHIBITING OTHER MUNICIPALITIES FROM BURYING
THEIR DEAD AT THE MUNICIPAL CEMETERY LOCATED AT BARANGAY
BUBUCS AND PROVIDING PENALTIES FOR VIOLATION THEREOF.**

WHEREAS, it has been observed that nearby Municipalities are using the Municipal Cemetery at Barangay Bubucos to bury their dead;

WHEREAS, this cemetery was established purposely intended for the benefit and exclusive use of the constituents of the municipality of Solsona;

WHEREAS, the municipal cemetery is already congested;

WHEREFORE, on motion of Sangguniang Bayan Jovencio M. Pascua, duly seconded by Hon. Rogerio E. Teodoro, be it Ordained that;

Section 1 - Other Municipalities are hereby prohibited from using the Municipal Cemetery located at Barangay Bubucos.

Section 2 - Anybody who violates the provision of this Ordinance shall be punished by a fine of not less than FIVE HUNDRED PESOS (₱500.00) but not more than TWO THOUSAND PESOS (₱2,000.00) or imprisonment of not less than TWO (2) months but not more than SIX (6) months or both penalty and imprisonment at the discretion of the court.

Section 3 - This Ordinance shall take effect after a lay of TWENTY ONE (21) days posting, after giving due notices to all nearby municipalities and after publication in a newspaper of Local circulation.

Copies of this Municipal Ordinance be furnished the Sangguniang Panlalawigan, Laoag City, The Municipality of Piddig, Municipality of Sarrat and Municipality of Garasi for their information and consideration;
