MUNICIPAL ORDINANCE NO. 160

**AN ORDINANCE IMPOSING PENALTY ON LATE REGISTRATION
OF BIRTHS, DEATHS AND MARRIAGES.**

WHEREAS, statistics shows that estimate of level of registration of births, deaths and marriages is only eighty percent (80%);

WHEREAS, in order to develop a comprehensive information system of civil status as a basis for the effective implementation of various programs of the government, the attainment of One Hundred Percent (100%) registration of births, deaths and marriages is imperative;

WHEREAS, late registration of said vital events has been a perennial problem;

WHEREFORE, on motion of Hon. Rogerio E. Teodoro, duly seconded by Hon. Agripino M. Estavillo, be it Ordained that:

Section 1 - A penalty amounting to FIFTY PESOS (P50.00) per annum or fraction thereof is hereby imposed to the person registering;

Section 2 - This Ordinance shall take effect after twenty-one days of posting in at least three (3) conspicuous places and after publication in a newspaper of local circulation;

Voting on the foregoing Ordinance, as follows:


