MUNICIPAL ORDINANCE NO. 161

**ORDINANCE IMPOSING ANIMAL DRAWN TO HAVE ANIMAL MANURE
CATCHER AND PENALTIES PROVIDED THEREOF.**

WHEREAS, horse manures scattered on the streets and roads
affect the cleanliness of the community;

WHEREAS, horse manures cause air pollutions and tetanus;

WHEREFORE, on motion of Hon. Luis B. Canal, and duly
seconded by Hon. Gervacio B. Vicente, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte,
that:

**Section 1 - All animal drawn vehicles be provided with
Animal manure catcher;**

**Section 2 - Any violation of this Ordinance be punished
by a fine of not less than ONE HUNDRED PESOS (P100.00) but not more
than TWO HUNDRED PESOS (P200.00) or an imprisonment of not less than
five (5) days but not more than twenty-one (21) days or both at the
discretion of the court;**

**Section 3 - This Ordinance shall take effect after a lapse of
twenty-one days posting in three (3) conspicuous places and publi-
cation in a newspaper of local circulation;**

Voting on the foregoing Ordinance, as follows:

Jonathan de Lara;**


