MUNICIPAL ORDINANCE NO. 173

AN ORDINANCE AUTHORIZING THE LOCAL CHIEF EXECUTIVE,
HON. JOSEPH E. DE LARA TO ENTER INTO CONTRACT AND
SIGN OTHER PERTINENT PAPERS RELATED THERETO THE
TRANSFER OF OWNERSHIP OF BLISS PROPERTIES LOCATED AT
BARANGAY MANALPAC, SOLSONA, ILOCOS NORTE BETWEEN THE
BLISS DEVELOPMENT CORPORATION AND THE LOCAL GOVERNMENT
UNIT OF SOLSONA.

WHEREAS, pursuant to the provision of Article 87 Section
VI of the IRR, RA 7160, the Sangguniang Bayan is empowered to grant
authorization to represent the Municipality in all its business
transactions and sign on its behalf all bonds, contracts and obli-
gations and such other documents made;

WHEREFORE, upon motion of Hon. Henry A. Batara, duly secon-
ded by Hon. Rogerio E. Teodoro and by virtue of the power vested
upon the Sangguniang Bayan and pursuant to the aforesaid provisions
of Republic Act 7160, be it Ordained, that:

Section 1 - The Local Chief Executive, Hon. Joseph E. de
Lara is hereby given the authority to enter into Contract to execute
and sign the transfer of ownership of BLISS site Manalpac, Solsona,
Ilocos Norte between the BLISS Development Corporation and the Local
Government Unit;

Section 2 - This Ordinance shall take effect upon approval;

Section 3 - Copies of this Ordinance be furnished the
Sangguniang Panlalawigan, Lacag City, the Regional Manager Feliciano
P. Reyes, Jr. of BLISS Development Corporation, 4th Floor Pines City
Golden State I, New Lucban Ext. Rd., Baguio City, for their informa-
tion and consideration;


