MUNICIPAL ORDINANCE NO. 174

AN ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO REPRESENT THE MUNICIPALITY OF SOLSONA TO ENTER INTO A MEMORANDUM OF AGREEMENT AND COMMITMENT BETWEEN THE DEPARTMENT OF AGRARIAN REFORM (DAR) FOR THE PURPOSE OF FACILITATING THE DELIVERY OF SUPPORT SERVICES IN FAVOR OF CATANGRARAN STA ANA, AGRARIAN REFORM COMMUNITY, SOLSONA, ILOCOS NORTE WHICH SHALL BE SOURCED FROM REGULAR OR CARP FUNDS.

WHEREAS, the Sangguniang Bayan is empowered to grant authorization to the Municipal Mayor, to represent the Municipality in all its business transaction and sign on its behalf all bonds, contracts and obligations and such other documents made, as mandated in the provision of Republic Act 7160;

WHEREFORE, on motion of Member Gervacio Vicente, seconded by all the members and by virtue of the power vested upon the Sangguniang Bayan, pursuant to the provisions of Republic Act 7160, be it Ordained that:

Section 1 - The Local Chief Executive, Hon. Joseph E. de Lara is hereby given the authority to represent the Municipality of Solsona, Ilocos Norte to enter into a Memorandum of Agreement and Commitment between the Department of Agrarian Reform for the purpose of facilitating the delivery of support services in favor of CATANGRARAN STA ANA, AGRARIAN REFORM COMMUNITY, Solsona, Ilocos Norte which shall be sourced from regular or CARP Funds;

Section 2 - This Ordinance shall take effect upon approval;

Copies of this Ordinance be furnished the Sangguniang Panlalawigan, Laoag City and Atty. Rogelio C. Arquillo, Provincial Agrarian Reform Officer, Provincial Agrarian Reform Office, Laoag City, for their information and consideration;
