MUNICIPAL ORDINANCE NO. 179

AN ORDINANCE AUTHORIZING THE MUNICIPAL TREASURER TO SETTLE AN OFFENSE CONCERNING CONFISCATED WEIGHTS AND MEASURES NOT INVOLVING THE COMMISSION OF FRAUD BEFORE A CASE THEREFORE IS FILED IN COURT UPON PAYMENT OF A COMPROMISE PENALTY OF TWO HUNDRED PESOS (P200.00).

WHEREAS, it has been observed that some confiscated weighing scales were rendered inaccurate due to mechanical defect beyond the control of the owner after it had been properly sealed;

WHEREAS, Article 234 states that the Sangguniang Bayan shall authorize the Municipal Treasurer to settle cases not involving the commission of fraud on weights and measures;

WHEREFORE, by virtue of the power vested upon the Sangguniang Bayan and upon motion of Hon. Rogerio E. Teodoro, duly seconded by Hon. Agripino Estavillo and Hon. Ismael Agulay, be it Ordained that:

Section 1 - The Municipal Treasurer is hereby granted authority to settle case/s on confiscated weights and measures not involving the commission of fraud upon payment of a compromise penalty of TWO HUNDRED PESOS (P200.00);


Section 2 - This Ordinance shall take effect immediately upon approval;


