MUNICIPAL ORDINANCE NO. 100

**AN ORDINANCE ADOPTING CLEANING AND GREENING OF
PHILIPPINE PUBLIC MARKETS.**

WHEREAS, Memorandum Circular No. 94-64 of the Department of Interior and Local Government, dated April 22, 1994 mandates the Cleaning and Greening of Philippine Public Markets;

WHEREAS, Executive Order No. 94-03 of the Local Chief Executive ordered the organization of a Task Force on Clean and Green Public Market;

WHEREAS, it is imperative that DILG Memorandum Circular No. 94-64 and Executive Order No. 94-03 of the Local Chief Executive be implemented in order to realize the value of a Clean and Green Public Market;

NOW THEREFORE, on motion of Hon. Henry A. Batara, unanimously seconded by all the members, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - The Cleaning and Greening of Philippine Public Markets, is hereby ADOPTED;

Section 2 - All provisions concerning the cleaning and greening of Public Markets be followed as mandated in MC 94-64 of the DILG and Executive Order of the Local Chief Executive No. 94-03, respectively;

Section 3 - This Ordinance shall take effect immediately upon approval;
