MUNICIPAL ORDINANCE NO. 186

AN ORDINANCE PROHIBITING THE MUTILATION OF TREEGUARDS,
CONSTRUCTED ALONG THE NATIONAL, PROVINCIAL, MUNICIPAL
AND BARANGAY ROADS AND OTHER PLACES WITHIN THE JURIS-
DICTION OF SOLSONA, ILOCOS NORTE AND PROVIDING PENAL-
TIES THEREOF.

WHEREAS, tree planting is in line with the Greening
and Cleaning Program of the government;

WHEREAS, treeguards protect the young trees from being
destroyed by animals;

WHEREFORE, be it ORDAINED by the Sangguniang Bayan of
Solsona, Ilocos Norte, upon motion of Hon. Luis B. Canal, duly
seconded by Hon. Agripino M. Estavillo, that

Section 1 - The destruction of treeguards constructed
along the National, Provincial, Municipal and Barangay Roads and
other places within the jurisdiction of Solsona, Ilocos Norte, is
hereby prohibited;

Section 2 - Anyone who violates the provisions of this
Ordinance shall be punished by a fine of not less than TWO HUNDRED
PESOS (P200.00) but not more than THREE HUNDRED PESOS (P300.00)
or imprisonment of not less than five (5) days but not more than
ten (10) days or both penalty and imprisonment at the discretion
of the court;

Section 3 - This Ordinance shall take effect after a
lapse of twenty-one (21) days posting in three (3) conspicuous
places;
