MUNICIPAL ORDINANCE NO. 208

AN ORDINANCE REQUIRING ALL MOTORIZED VEHICLE OWNERS
OPERATING WITHIN THE JURISDICTION OF SOLSONA TO INSTALL
SILENCER ON THEIR VEHICLE AND PROVIDING PENALTIES IN
VIOLATION THEREOF.

WHEREAS, it has been observed that many vehicles create
noise that are irritating;

WHEREAS, the installation of silencer can at least mini-
mize such irritating noise;

WHEREFORE, on motion of Hon. Gervacio B. Vicente, duly
seconded by Hon. Agripino M. Estavillo, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos
Norte, that:

Section 1 - All Owners of Motorized vehicles are hereby
to install silencer on their vehicle;

Section 2 - All Owners who neglect to install silencer on
his vehicle shall be penalized by a fine of not less than ONE
HUNDRED PESOS (100.00) but not more than FIVE HUNDRED PESOS
(500.00) or an imprisonment of not less than six months or both
at the discretion of the Court;

Section 3 - This Ordinance shall take effect after 21 days
of posting in conspicuous places and after publication in a news-
paper of local circulation;

Copies of this Ordinance be furnished the Sangguniang Pan-
lalawigan, Laoag City and all others concerned for their information;






