MUNICIPAL ORDINANCE NO. 216

AN ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR, HON. JOSEPH E. DE LARA TO REPRESENT THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF AGRICULTURE REPRESENTED BY DIRECTOR ROGELIO V. SIGNEY FOR THE IMPLEMENTATION OF THE GRAINS PRODUCTION ENHANCEMENT PROGRAM (GPEP).

WHEREAS, pursuant to the provisions of Article 87, Section VI of the IRR, R.A. 7160, the Sangguniang Bayan of Solsona, Ilocos Norte is empowered to grant authorization to the Local Chief Executive to represent the Municipality in all its business and sign in its behalf all bonds, contracts and obligations and such other documents made;

WHEREFORE, on motion of Hon. Henry A. Batara, duly seconded by Hon. Jovencio M. Pascua, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - The Local Chief Executive, Hon. Joseph E. de Lara is hereby granted the authority to enter into a Memorandum of Agreement with the Department of Agriculture, Regional Field Office No. 1, represented by its Director Rogelio V. Signey;

Section 2- This Ordinance shall take effect immediately upon approval;


