MUNICIPAL ORDINANCE NO. 224

AN ORDINANCE OF TEMPORARY CLOSURE OF SOME PORTIONS
OF THE NATIONAL, PROVINCIAL AND MUNICIPAL ROADS DURING
THE SOLSONA TOWN FIESTA '95.

WHEREAS, the annual celebration of the Solsona Town Fiesta
'95 will be on January 20 to 22, 1995, respectively;

WHEREAS, numerous sideshows will grace the occasion;

WHEREAS, for the past several years, the playground in front
of the Roman Catholic Church was used to be the usual place of side-
shows during Town Fiesta, however, the municipality is surprised for
the sudden prohibition of the Bishop of the Roman Catholic Church;

WHEREAS, because of the instant prohibition of the Bishop
to use the playground, there is an urgent need to temporary relocate
the sideshows, to some portions of the National, Provincial and Munip
cipal Roads and re-route the traffic;

WHEREFORE, on motion of Hon. Henry A. Batara, unaniamously
seconded, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte,
that:

Section 1 - Some portions of the National, Provincial and
Municipal Streets inside the Poblacion be temporarily closed;

Section 2 - This Ordinance shall take effect immediately;

consideration;
