MUNICIPAL ORDINANCE 245

AN ORDINANCE NAMING THE CHILDREN'S PLAYGROUND INTO  
DON FEDERICO DE LARA PARK LOCATED AT BARANGAY  
LAURETA, SOLSONA, ILOCOS NORTE.

WHEREAS, Resolution No. 16 of the Barangay Council  
of Laureta recommended to the Sangguniang Bayan of Solsona,  
Ilocos Norte naming the children's playground to Don Federico  
de Lara Park;

WHEREAS, upon consultation with the National Histo-  
rical Institute, Resolution No. 16 of Barangay Laureta be  
accommodated and interposes no objection to such proposal;

NOW THEREFORE, on motion of Hon. Henry A. Batara,  
duly seconded by Hon. Agripino M. Estavillo and Hon. Antolin  
D. Refani;

Be it Ordained by the Sangguniang Bayan of Solsona,  
That:

Section 1 - The children's playground of Barangay  
Laureta will be named in Honor of the Late Don Federico de  
Lara;

Section 2 - This Ordinance shall take effect TWENTY  
(20) days after posting at conspicuous places and publica-  
tion of newspaper of Local circulation.

consideration.
